Bylaw No. 15/93

A BYLAW TO REGULATE THE OPERATION OF  
SKATEBOARDS, ROLLER BLADES AND TWO-WHEELED SCOOTERS.

The Council for the Town of Dalmeny, in the Province of  
Saskatchewan, enacts as follows:

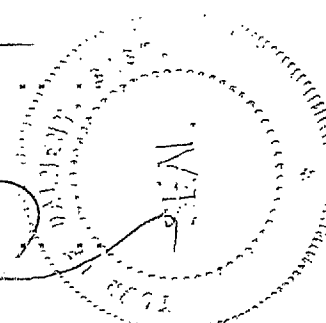
1. Subject to Section 5, no person shall operate, ride upon or otherwise propel a skateboard or two-wheeled scooter or continue to operate, ride upon or otherwise propel a skateboard or two-wheeled scooter in any public place listed in Appendix I of this bylaw.
2. Any owner or any agent of any owner of any place of business or institution to which the public has access as of right or by invitation, express or implied, may, in writing, authorize members of the police service to enforce the provisions of this bylaw on said property.
3. No person shall operate, ride upon or otherwise propel a skateboard or two-wheeled scooter or continue to operate, ride upon or otherwise propel a skateboard, roller blades or two-wheeled scooter in any private place with public access as listed in Appendix II of this bylaw.
4. Letters received by the council pursuant to Section 2 shall be attached to and form part of this bylaw.
5. The Chief of Police may, from time to time, authorize the operation of skateboards in designated public areas for the purpose of display or competition.
6. Any person who contravenes the provisions of Sections 1 or 3 is guilty of an offence and upon summary conviction is liable to a fine of not less than twenty-five dollars (\$25) for the first offence and not less than fifty dollars (\$50) each subsequent offence.
7. A police officer who finds anyone in contravention of the provisions of Sections 1 or 3 may seize the skateboard, roller blades or scooter for a period not exceeding thirty (30) days.
8. Upon expiry of the thirty (30) day period police shall return the skateboard, roller blades or scooter seized in accordance with Section 7 to the person from whom it was seized.

APPENDIX I of Bylaw No. 15/93.

(Pursuant to Section 1)

"Prohibited Skateboarding Areas - Public"

1. Heritage Park - within the confines of the fenced enclosure;
2. Third Street - between Railway Avenue and Wakefield Avenue;
3. First Street - between the south boundary and the north boundary of the municipality;
4. Railway Avenue - between First Street and Main Street;
5. Railway Avenue - the concrete driveway at the front of the fire hall.

APPENDIX II of Bylaw No. 15/93.

(Pursuant to Section 3)

"Prohibited Skateboarding Areas - Private"

1. Third Street - the parking lot and sidewalks at Dalmeny Agencies and Hairways salon;
2. Highway #305 - the lot and buildings at Dalmeny Car Wash;
3. First Street - the parking lots, service areas, driveway and sidewalks at Spruce Manor Special Care Home;
4. Third Street - the parking lot and sidewalks at the mall.
