**EAST DRAINAGE CONTROL:**

**28/12 – Bradley/Pryma** – That Option A for berming of east area of town owned 80 acres (S1/2-11-39-6-W3) as provided by town engineers, be approved for construction in 2012, provided that the RM of Corman Park enter into agreement with the Town of Dalmeny to mow cattails located on this land, for a minimum period of 10 years (2012 to 2021), and that the agreement contain a renewal clause.
