**BYLAW 2/12 – BYLAW TO PROVIDE FOR THE AMENDING OF BYLAW 1/12:**

**47/12 – Bradley/Mierau** - That Bylaw 1/12 being a bylaw to provide for amending of Bylaw 1/12, the water & sewer rates bylaw, be introduced and read a first time.

**MOWING AGREEMENT WITH RM OF CORMAN PARK:**

**51/12 – Bradley/Pryma** – That, as first outlined in Motion 28/12 adopted by Town Council at the February 27/12 council meeting, the Town of Dalmeny enter into an agreement with the RM of Corman Park, for RM to mow cattails on the S1/2-11-39-6-W3 at no cost to the town, for a period of 3 years, 2012 to 2014 inclusive, with a renewal clause.

**EAST DRAINAGE CONTROL:**

**52/12 – Bradley/Pryma** – That Option A for berming of east area of town owned 80 acres (S1/2-11-39-6-W3) as provided by town engineers, be approved for construction in 2012, provided that the RM of Corman Park enter into agreement with the Town of Dalmeny to mow cattails located on this land, for a minimum period of 10 years (2012 to 2021), and that the agreement contain a renewal clause.
