
The CAO read Bylaw 2-2026 a third time, and the Mayor and CAO signed and sealed the bylaw.

BYLAW NO. 2-2026

A BYLAW OF THE TOWN OF DALMENY TO AMEND BYLAW NO. 1/12 WHICH PROVIDES FOR FIXING WATER RATES AND SEWER SERVICE CHARGES

The Council of the Town of Dalmeny, in the Province of Saskatchewan, enacts as follows:

1. The rates to be charged as a water consumption charge, an infrastructure fee and a penalty interest rate shall be those as set out in Schedule "A" attached hereto which shall take effect on March 1, 2026.
2. The rates to be charged as a sewer consumption charge, an infrastructure fee and a penalty interest rate shall be those as set out in Schedule "B" attached hereto which shall take effect on March 1, 2026.
3. The rates to be charged as a water consumption charge, an infrastructure fee and a penalty interest rate shall be those as set out in Schedule "C" attached hereto which shall take effect on January 1, 2027.
4. The rates to be charged as a sewer consumption charge, an infrastructure fee and a penalty interest rate shall be those as set out in Schedule "D" attached hereto which shall take effect on January 1, 2027
5. Bylaw No. 11-2023 and 1-2026 are hereby repealed.
6. The rates, charges, tolls or rents contained in this bylaw shall come into force and take effect on the day of approval being issued by the Local Government Committee.
